Gentleman and Ladies:

My name is Joseph Fernandez. I am 17 years old. I'm writing to you as a concerned American citizen on behalf of hundreds of children. I come to you with a plea for assistance. I am the son of Aida Fernandez, and Jose Fernandez, who wrote to you in

September, 2011, informing you of the abuses that were being committed in Miami Dade County, Florida, in the Miami Land Grab case.

It is inconceivable, and un-American that in the United States, other children like me and including me, have to live with the fear and uncertainty in our lives due to the illegal harassment, persecution, and intimidation that our parents have been forced to live with.

Due to the tyranny imposed by the corrupted Miami -Dade government with the complicity, and support of many judges from the 11th Judicial Court under the control and guidance of Mr. Harvey Ruvin we get no justice. Mr Ruvin is acting as an agent of United Nations and for the last 25 five years has implemented the unconstitutional UN Agenda21 which states that private property belongs in the hands of the government not individuals.

When I was 13 years old, I was experiencing throughout my life many helicopters flying very close to the roof of my house, making every window and wall shake. In those times I would find comfort in going into my room. In 2011, I had to leave the United States with my mother, who went to court to defend our family and was issued a contempt citation, as an exile for the safety of our lives. My family was constantly told to leave our home we don't belong there.

No American child should have to go through these experiences of abuse from our government. I have lived through the experience of the fire that was purposely set in the barn containing people and many beloved horses. These horses included the ones that my parents held close to their hearts and were part of our family. The entire barn was set on fire. Thankfully, our neighbors survived. Fortunately, my father saw the fire and immediately went to help everyone out, including most of the horses, but 5 of the horses were consumed by the fire. This happened the night after a radio program where my mother had a heated debate with now former Director of DERM (Department of Environmental and Resource Management), Carlos Espinoza. Many people asked for an investigation at the time but to no avail. The fire was classified as accident and removed from the media.

We moved our mare to our farm and on December, 2011, my father, Jose Fernandez, gave evidence and information to the TASKFORCE (circus) that was supposed to investigate all of these crimes. A few weeks after the mare was assassinated over night. Many people of the community had tried to go to the local police department, and inspector general and any agency that supposedly investigate corruption in the government, but again to no avail. They couldn't even get an appointment to be heard.

Just so you know, one of the first decisions made by Miami-Dade County Mayor, Carlos Gimenez, was to dismantle team of investigators that were in charge and had the authority to investigate government corruption. At this time, there is no one to defend we the people against the corruption of government officials. Today I am 17 years old, and I can no longer accept the pressure that I am living under for the fear that my mother and I are in danger. My family was destroyed, my parents business was illegally closed. We lost everything we had due to us trying to protect ourselves under the court system. I have to see my father every 2 months to avoid being harmed by the government.

At this same time, Mr. Harvey Ruvin, using his influence and control on the judges, made Judge Marc Schumacher illegally manipulate every court procedure and had authorized an emergency eviction of my father and my 90 year old grandfather. I am in fear for their lives.

I will explain, on December 17, my father received a letter that came through the normal mail, requiring an emergency hearing for his eviction. The hearing was set for December 18, at 10 o'clock in the morning. My father went to see a lawyer that is helping him Pro bono.

He's helping my father by going to court on behalf of my father since my father has a restraining order from being in the 11th civil judicial court, which was a request by Harvey Ruvin.

At the hearing in the morning, when the lawyer showed up, Judge Marc Schumacher cancelled the hearing. Later on that same day, he went on with the hearing without advising my father or his lawyer. At that time the judge signed the authorization for the emergency eviction. Later on that same judge sealed the entire case. It should be noticed that my fathers lawyer, for the last four months, went multiple times to the court to ask for the papers of the foreclosure case. He was told every-time that the papers were no where to be found. After all of this, my father's lawyer put a motion to stop all of this illegal and criminal acts being committed by Judge Marc Schumacher, in front of Judge John Schlesinger, who ruled against my father in favor of the illegal procedures that were committed by Judge Marc Schumacher. Judge Marc Schumacher retired right after committing them. My father's lawyer put in a new motion in front of the third district court which is where the case is now. This judge found enough evidence to hear the case.

At this time, there is no government agency, or department assisting us in our time of need. There is no way that we can find justice or even acknowledgement at a local level. You, as our representatives, have to get involved and start an investigation of the corruption in Miami-Dade County. This letter will be shared with a lot of concerned

American patriots, and you'll will be partly responsible of any tragedy that comes out of this ordeal. To witness a crime, and do nothing about it, makes you part of the crime.

As you watch this video, I had been ambushed on the corner of my street, hand-cuffed, and put in a police vehicle, by three or more Police Officers, at gun point.

On February, 17th, 2015, I went to pick up my correspondence on the isolated corner of the street in front of my house. As I was opening the door of my car, I was abruptly confronted by a few police officers pointing their guns at my head. I acted calmly and consented with duly respect to follow their orders. I was hand-cuffed and thrown into the back of a police unit for over half an hour without any explanation. I was NOT I told that I was under arrest. At that time, more than twenty police units, six undercover units, one bomb squad truck, and a helicopter arrived at my house. You won't see that amount of force because they arrived after the cameras surrounding my house were shut off.

In my opinion, this was a coordinated attempt to kill me if I would've reacted in the wrong manner, and also, to inflict a heart attack on my 90 year old father who was taken out of the house in front of more than eight to ten fully armored and armed police officers. Thanks to the professionalism and calmness of the police officers involved, who were misled into thinking that they were confronting two dangerous criminals, my father was able to overcome and survive what could've been a traumatic tragedy.

All of this was planned by Harvey Ruvin, with the assistance of Judge Michael Schumacher (who immediately retired to run away from what he's done). We can't forget one of the other accomplices which was none other than Duetsche Bank National Trust Company, their lawyers, and some unknown high ranking official from the Miami Dade County Police Department.

Up until today March 13, 2015, I still haven't received a notice of eviction, nor have I received any paper or record of this entire operation that put the lives of my 90 year old father and myself at risk.

How many thousands of taxpayer dollars do you think they wasted on this operation?. Was it necessary? I will answer this question for you.

During the last few months, a great American patriot whose name is John Dubois, president of Miami Dade Citizens for Property Rights, has been protecting me. John fights and protects the citizens who have been abused by the government. He had been in constant contact with Miami Dade County Police Sergeant, Richard Hernandez, who is also a part of the Homeland Security division. John Dubois and I had been proposing to Richard Hernandez to visit my house with any number of police officers, to ensure his protection. We wanted a friendly discussion about the situation, and to show him that there was no risk nor was there any intention of any harm being done to any police officers who I have supported and still do to this very day.

Unfortunately, he ignored our proposition and instead decided to go on with this attempt on the lives of my father and myself. I won't mention the names of the police officers but all of them made the comment that they were set up. They also mentioned, that in a way, a crime was being committed. I lost everything I had.

I was told by police they were told by a sergeant that I could not return to my property. Meanwhile the property is being vandalized with no one there to protect it. Most of my stuff was destroyed since they put some of it on the back of some trucks contracted by

the Deutsche National Bank while it was raining. Most of my things were left outside in the rain until the next day. My things left in the house are now being vandalized. Today, thanks to my sister, I have a cot in her house so I have a place to sleep.

I have never asked nor have I accepted any donations. This time all I ask from you is to send and spread the video with the message attached to every one you know, especially, the Florida Representatives and those listed above. I want all of you to realize that if they get away with this crime, you might be next on their list.

It is time to let the truth come to light and out of the darkness. I have lost my company, my land, my family, my house, everything I had, but I will never lose the hope on you the American people, and the appreciation and support of those police officers who avoided a possible tragedy. I will also include a video posted on February 6 on my YouTube and Facebook inviting the police to come and inspect my house.

God Bless America, God Bless our Constitution, God Bless our Police Officers. God damn the corrupted politicians, and public officials who use the color of law to take away our constitutional rights. I will keep fighting until I die.
