Who controls Florida?

The following information comes from the U.N. Johannesburg 2002 Summit. (US Profile). On page 108, it states that the three most important components' to implement "Agenda21" are at a local level:

- 1.) The National League of Cities, (NLC),
- 2.) The National Association of Counties, (NACo),
- 3.) The International City/County Management Association, (ICMA). This is referred to as Local Agenda21, (LA 21).

All three of these organizations have State chapters, working toward the same agenda in your community with your board of commissioners and city councils. This is how it works:

The National League of Cities (NLC) has a State chapter, **Florida League of Cities (FLC)**. The National League of Cities is directly connected to the United Nations. Our elected officials give them taxpayer dollars to lobby for U.N. Treaties.

In addition a recent UN Lobbying effort was on Gun Control for Americans. George Soros a Billionaire, with hard core communist leanings, working to destroy the United States helps fund their lobbyist. They endorse One World Government. The Florida League of Cities helps to implement these initiatives at a local level. They promote sustainable development, man made global warming, land acquisitions, permanent easements,

This is how it works:

The National League of Cities (NLC), State chapter, **Florida League of Cities (FLC)**. The National League of Cities is directly connected to the United Nations. They use taxpayer dollars to lobby for U.N. Treaties.

A recent UN Lobbying effort was on Gun Control for Americans. George Soros (is a Billionaire, with hard core communist leanings, is working to destroy the United States helps fund their lobbyist.) They endorse One World Government. The Florida League of Cities (FLC) helps to implement these initiatives at a local level. FLC promotes sustainable development, man made global warming, land acquisitions, permanent easements, social justice, Regionalism, all programs of Agenda21. NLC works directly with FLC who works with ICLEI, (The International Council for Local Environmental Initiatives). These NGO's are the right arm marketing the programs of the United Nations. The Florida League of Cities lobby our State Legislators on these agendas. They work hand in hand with the Florida Association of Counties, and the Florida City/County Management Association; both promote Agenda 21. Just check their web sites.

Next is the **National Association of Counties (NACo)**, the state level is the Florida Association of Counties (FAC). The National Association of Counties is the only lobbying organization that represents counties at a Federal level. **NACo supports U.N. Treaties, such as the "Law of the Sea", which is chipping away at the sovereignty of the United States giving the United Nations a percentage of our oil and mineral rights, as well as control over the United States Coastal Line!!!** (Reread that sentence. We are losing our sovereignty via unconstitutional treaties and depleting our resources, wealth, and land as well.) The latest treaty is called the Trans Pacific Partnership where all of the US will be controlled by the UN international law.

Treaties that do not follow the constitution are UN-Constitutional. Article VI, Paragraph 2 of the Constitution is commonly referred to as the Supremacy Clause. It establishes that the federal constitution and federal law generally, take precedence over state laws, and even state constitutions *AS LONG AS ALL LAW FOLLOW THE CONSTITUTION. INCONSTITUTIONAL LAW IS NOT SUPREME.*

The Constitution is the Law of the Land, and foreign entities do not supersede it! Treaties that the United States have signed onto with the United Nations giving away rights and sovereignty of Americans **ARE NOT VALID and are illegal.** The problem is the legislators that have no idea of the meaning of the Constitution.



AMERICAN FREEDOM “Private Property Ownership”

These organizations work directly with the United Nations, promoting Agenda21 and all policies that go with it. The Florida Association of Counties (FAC), keep in mind every county in Florida belongs to FAC, lobby our State Legislators with their agenda, using your COUNTY TAX DOLLARS! They do not work directly with the United Nations, but through and with many other U.N. organizations.

ICLEI is an organization that uses taxpayer dollars provided by many municipalities as dues to implement their programs. We have noticed over time as soon as we find out the connections, the names get changed and the information gets scrubbed. The old name International Council for Local Environmental Initiatives (ICLEI) has been changed to Local Governments for Sustainability.

To add insult to injury, when confronted with documents from the FAC website at a commissioners meeting, Chris Holly (FAC Director), went back to Tallahassee, and scrubbed the word ICLEI and all the programs they work with off the site. Why?

The Florida Association of Counties also endorses and supports the Florida Forever amendment for the 2014 Ballot giving Florida Forever \$10 Billion (taxpayer dollars) to control more land through more land acquisitions and permanent easements. **Florida Forever already owns 28% of Florida Land!** How much is enough? Every time more land comes off our tax rolls this lost revenue must be made up by new taxes. NACo also promotes more powerful government at a Local, State level and Federal Level.

The third is the **International City/County Management Association (ICMA)**, State chapter, Florida City/County Management Association (FCCMA). The International City/County Management Association uses new words to describe the same program like Livable Communities instead of Sustainable Development or Downtown Restoration. (Beware) They work directly with the United Nations. They subscribe to Social Justice, Land Acquisitions, and Permanent Easements, and promote Regionalism. They also work with ICLEI, NLC, and NACo. They work at both at the city and county level. Randall Reid was recently fired by Sarasota commissioners, as county administrator. He is a member of ICMA and FCCMA, and sits on the board of Foundations of Counties, through Florida Associations of Counties. He wrote a speech on the “Moral Imperative” that he gave around the country. It was based on Sustainable Development, Social Justice, section 8 subsidized housing and open

spaces! He has held thirty some positions in office across Florida at local levels, promoting U.N. policies. FCCMA has the same agenda as the (ICMA),

How can the United Nations (with only three organizations) achieve their agenda at a local level?

They sell their policies to communities as a way to prosper using sustainable programs that are overly expensive, have no scientific basis and are designed to fail. These policies are at the root of the economic failure and massive debt. With the man made sorry economy we have had for several years our communities are easy prey once commissioners smell the "Free" money. Most municipalities have no idea of what they are getting into. Sadly these organizations use that to their benefit.

In other communities, commissioners and city council members are often members of these organizations and know exactly what they are doing. Some local governments belong to all three. County commissioners and city council members will defend and deny what they are doing and what they stand for. Do not be fooled. They will try to dismiss everything anyone says by telling you, "Don't you want to care for the environment?" Once your board is controlled by their policies and implement them, you will see roads deteriorate, private property diminish and massive spending creating massive debt. Miami is near bankruptcy. You must check with your city/county to see what memberships they have and see if any of those mentioned in this article are in your community. Then go to your county appraiser and ask, "How much land in our county is not taxed? Who owns the land not taxed?" Approximately 80% of Taylor County FL land does not pay taxes. Why? Next time you are told of a tax hike, tell you officials to go after those not paying taxes.

If your community is involved, you must request and then demand that they stop their memberships and stop paying dues. These organizations work with your regional councils and planners to get your board to accept Sustainable Development grants, through HUD, EPA, DOT (Dept. of Transportation, and Water Management Districts). All of these grants come with strings attached. Remember Federal and Government Grants are your tax dollars being recycled for others to use. When your community applies for a government grant there are strings attached and specific requirements for the use of the money. Private grants are the only acceptable form of grant for your community to consider. Abusive programs like: Restore Act, Community Reinvestment Act and forced Section 8 Housing will re-engineered your community whether you like it or not. The sole purpose of these programs is to own and control your private property. The organization's goal is for the loss of your property rights, liberty, and the indoctrination of your children. Why?

The UN follows the Communist Manifesto. The objective of communism is to eliminate the middle class. ***"The way to crush the bourgeoisie(middle class) is to grind them between the millstones of taxation and inflation."*** Vladimir Lenin Communists believe that only those that can have land or wealth, must be determined by the government. Social justice, urban renewal and development, the provision of decent dwellings and healthy conditions for the people can only be achieved if land is used in the interests of society as a whole.*"

Currently there are hundreds of NGO's all following the same regional programs designed to push humans into urban containment units with uniform housing. Rural areas with individual designs and individual land boundaries are called "sprawl" and must be eliminated. In a report from the unconstitutional North West Florida Green Infrastructure

1. Establish and adhere to URBAN CONTAINMENT BOUNDARIES;
2. Offer housing diversity for all ages through affordable housing strategies and homes of all sizes for all stages of life. (build section 8 houses)
3. LIMIT SERVICE PROVISION (NO SERVICING ABOVE A CERTAIN ELEVATION OR OUTSIDE THE CONTAINMENT BOUNDARY). This includes ROADS, SEWER AND WATER LINES, FIRE PROTECTION AND POLICING.

Please remember, your local government uses your tax dollars (your money) to implement these programs... Stop funding these groups, go to your city and county boards. Demand that they drop these organizations and do not implement their plans.
