

**All Americans Care about All Government Corruption of the U.S. Constitution,
In the Interest of the General Welfare, there is Reason to
Investigate International Organizations Receiving Public Funds.**

Whereas, all Americans are affected by the **systemic international interference in governance** across America by **organizations funded with public dollars operating within government without general public knowledge**, we petition our elected representatives at all levels of government to **investigate such groups**, and

Whereas, **at least one such organization has caused transformation of America's local governments by signed oath of its public sector members** which no public servant is authorized to do, and

Whereas, **an undisclosed number of ICMA member public managers serving across America did sign the ICMA oath to do so**, and **state and local regulation limit political activity of public managers in jurisdictions across the country**, and

Whereas, public funds were used to purchase membership and services from the **International Council for Local Environmental Initiatives** and their partner, the **International City/County Management Association** which **have caused to be implemented transformational regional governance in defiance of Constitutionally-defined electoral district representation of citizens**, without public debate or consensus, and

Whereas, **the very nature of municipal memberships and their political activity is not transparent**, and

Whereas, a **conflict of interest exists** within government organizational structure among those elected and appointed office-holders, administrative department heads, staff, Attorney, constitutional officers, committees, and government stakeholders who have access to information related to the matter of **compliance with oath of office and other restrictions on public servants**, and

Whereas, fear of retribution, loyalty, restraint, or constraint **may interfere with the integrity of internal inquiry regarding compliance with oath of office**, and

Whereas, **the general welfare of all communities in America is at further risk**, and

Whereas, in at least one known case, Pinellas County, Florida, has **failed to produce public records** within a "reasonable time", as required by the Freedom of Information Act, without redress after 3 months' time, said records regarding **all organization memberships which are budgeted with public funds and approved by the Board of County Commissioners annually**, and

Whereas, that County has **failed another FOIA request for all related information about ICLEI**, and

Whereas, **American citizens have no other means of redress than to petition a higher authority in such cases as Pinellas as well as in all affected American jurisdictions yet undiscovered**,

Whereas, the **Administrator and Pinellas Commissioners continue to spend public dollars on ICMA despite objections and revelations as to the intent of ICMA to avert district representation**,

Now therefore, we the undersigned American citizens affected, do demand a **Florida state independent and impartial investigation of Florida public managers** and their political activity, and all political activity of all **membership groups paid with public funds, as well as any and all parties who have knowledge of any and all of the political activity of public managers beginning from the time of application** for employment until the present, and

Therefore, we further demand that all information and related costs revealed by such investigation including lobbying by any party, regional planning partnerships for land-use and transportation, non-profit advocacy, etc., **be made public and that county code and Florida statutory action be taken as appropriate**, and

Therefore, we further demand that **every Florida household receive, by US Postal Service, disclosure of oath of office violation revealed in the investigation to include how to access all the results on municipal websites for a period of 2 years, so that every American across the country may also access the information and be alerted to investigate their own communities** for organizations that subvert the U.S. Constitutional form of government representation.
