Fire Boehner: We Only Need 16 Votes to Depose Boehner

If conservatives want to keep the House and win the Senate, we need to fire John Boehner as speaker of the House. We only need 16 House votes to do it.

As most conservatives know, Boehner and the House GOP Steering Committee decided to purge four conservative House members from their committee. Congressmen Justin Amash and Tim Huelskamp were removed from the House Budget Committee, and Congressmen David Schweikert and Walter Jones were cut from the Financial Services Committee.

Amash, Huelskamp, and Schweikert were targeted because they were too fiscally conservative—all three have voted against Boehner's debt ceiling hikes. Amash and Huelskamp were the only two GOP votes against House Budget Chairman Paul Ryan's budget.

Amash explained that vote at yesterday's Bloggers' Briefing at the Heritage Foundation, "It's unacceptable to have unbalanced budgets until 2040."

For anyone outside of DC, this statement seems obvious. Only in Washington is balancing the budget radical.

Many conservatives voted for the Ryan budget because they didn't want to "let the perfect be the enemy of the good." I understand that, but we shouldn't criticize those who actually understand the depth of our debt problem and plan to propose real answers.

If Speaker Boehner wants to purge independent, bold conservatives—I think it's time he gets fired as Speaker. Not only for the purge. He has failed to effectively win negotiations with President Obama and appointed moderate committee chairs. To the public, Boehner may appear radical but in reality he proposes milquetoast policies, like the tax-hikes he proposed this week.

While the caucus has already voted in support of John Boehner as speaker of the 113th Congress, the final floor vote doesn't happen until early January.

Everyone thinks it's a fairytale, but the Conservative Movement is capable of firing Boehner with just 16 votes.

The House rules demand that a Speaker receive a majority—218 votes—to be elected speaker. If no nominee for speaker receives 218, the House remains speakerless—as it did during parts of the Civil War.

If 16 House Republicans were to abstain from voting for Speaker, Boehner would only receive 217 votes.

Once we depose Boehner and cause a firestorm, the Republican caucus will get the memo: Pick someone else! These 16 Republicans only need to hold out until the caucus chooses a new leader.


For Speaker, I suggest members who are antiestablishment, but still have broad support. Congressmen Jim Jordan of Ohio would be my pick. He just finished leading the Republican Study Committee and proposed the best budget we've seen come out of Congress.

Frederick Douglass: Patriot

"....he is a lover of his country who rebukes and does not excuse its sins."

Frederick Douglass was many things during his life: runaway slave, famed orator, adviser to presidents but it was after visiting his house today that I learned that Frederick Douglass was a great patriot and one of our greatest Americans.

It's generally accepted that a patriot is someone who loves their country and (in our case) sees the world through red, white and blue colored glasses. In post 9/11 America, we consistently hear that there are people in this world who not only hate America, but also the lives we lead as Americans. Douglass lived in a country that celebrated freedom and liberty while keeping slaves in bondage and denying rights to many different types of citizen. He not only recognized this hypocrisy but he also let people know about it through his writings and speeches, specifically the beautiful, scathing and ultimately truthful "rebuke" of our Independence Day in his 1852 speech, What to an American Slave is the Fourth of July? This doesn't mean that he hated America, it just means that he cared about the country and its people. This idea of "tough love" translates to many relationships in life including parent to child and teacher to student. Multiple times during my three years in the classroom I have pushed

students to be better because I've seen the potential in them; their response is usually questioning why it is that I hate them. Much like Douglass and 19th century America, I just want them to live up to the high standards that have been set for them.

Sadly Douglass was not alive for Jim Crow in the 20th century but while he was here, he gave America exactly what the country needed and what each of us needs at different times in our lives: someone to get in our ear, tell us we're acting like fools and to cut the crap. Whether it was the abolition of slavery, or the rights of women and free blacks, Frederick Douglass pushed America to live up to the lofty standards set by our founding fathers and by doing so he helped America become a better place.

Thank you Mr. Douglass, for not only changing America but also for teaching me how to truly love my country.

Former AZ Sheriff Directs Traffic in NYC

Ten years after one of the worst and most horrific attacks in American history, I found myself in the middle of New York City directing traffic. Yes, a former small-town Arizona sheriff stood in the middle of one of the largest and busiest intersections in all Manhattan, telling a bunch of New Yorkers how to drive. (That in and of itself is a life and death proposition.) But in this moment of personal frustration I could not help it. I had to do something. I could not sit one moment longer in that stuffy old taxi.

You see, this was New York City in rush hour traffic on Friday afternoon, where a trip from JFK Airport normally takes 30-40 minutes to Times Square. On September 9, 2011, it took three hours (no exaggeration). So after tolerating moving barely ten feet in 30 minutes I had had enough. I got out and slammed the door of the cab, and with my wife's approval, headed into the concrete jungle of New York determined to do something about this ridiculous traffic jam. If nothing else, at least I had the opportunity to stretch my legs for a minute.

I walked about four blocks and found the intersection causing all the congestion. Southbound traffic was a four or five lane one way street, and Westbound traffic was three lanes. Cars from both directions were all crowded into the intersection and nobody was in the mood to allow the other guy a single inch. All the motorists were just as frustrated as I was. I walked nervously into the intersection and stood in front of all the cars heading South and raising both my hands high above my head I shouted out orders for everyone to stay put. They all obeyed and seemed relieved someone was actually doing something, even if it was an obvious tourist wearing a bright Hawaiian shirt. What I needed was a whistle, but sorry, my briefcase

contained no such emergency equipment. So my shouting and hand gestures had to suffice.

As I continued to clear the intersection, I have to say I was amazed and gratified with the amount of cooperation I was receiving, even from the Taxi drivers. I had to watch my back though, as it was difficult for all Southbound motorists to see me at the same time.

As I continued my impromptu traffic control I was pleasantly surprised by all the shouts of *Taken with my wife's cell phone* thanks and congratulations from passing New Yorkers. I was called a "good Samaritan" several times and even "hero" from a bunch of "Cholos" driving through in their low rider. Then my wife called on my cell phone. "Hey, it's working, we're moving. Be ready to get back in the cab; we're just a half block from the intersection," she informed me excitedly. I thanked her for the tip and hung up quickly as some pedestrians patted me on the back.

Then right when things were settling down and traffic was moving smoothly a young woman came up to me in the crosswalk and announced rather emotionally, "I just called New York PD and told them what you're doing." My heart sunk, "Oh man, here it goes, they're going to arrest me for getting in the street or for impersonating an officer," I thought to myself. Then the lady finished, "I told the cops to get out here and do their job instead of leaving it to a tourist!"

This supportive local thanked me and I her and sure enough, from my left I noticed two uniformed cops heading right towards me. I waved and headed back to my cab. My wife had the door open acting all worried that I would not make it in time to jump aboard. I sat down and took a deep breath, "whew, I did it!" "Yes, you did," she replied enthusiastically. We looked at each other momentarily and busted out laughing. She finished this scene with one final conclusion, "You're a nut," she said with a chuckle. I couldn't argue with her on that one.

I thought as we moved along through somewhat lighter traffic how amazing this entire moment really was. I had actually stood in the middle of a huge intersection in one of the largest and most amazing cities in the world, ten years nearly to the very day of the 9-11 attack, working together with a bunch of strangers to solve a problem. Maybe there's a parallel here; do you think perhaps this is how we could heal America?

I do have to add, the Liberty Fest I spoke at on Saturday was a great event. The 800 people there were fantastic. The people of NYC were fantastic, friendly and caring. There were thousands of visitors for the 9-11 ceremonies and there was a spirit of reflection and mourning and togetherness. Maybe my brief moment of standing in the intersection taught me that perhaps all it takes to clean things up and get things moving again; is somebody taking a stand and getting the people stuck in a mess to work together. I can think of no better way to commemorate the anniversary of the 9-11 tragedy, directing traffic in NYC at 63rd Street and Queensboro.

Florida AG Bondi fights against gun rights

The Florida Supreme Court is currently reviewing the case of Mackey v. State of Florida to determine whether an investigatory stop, and a search and seizure of a person suspected to be carrying a concealed firearm, is lawful.

Conflicting case law lands this matter at the highest court in the State. By statute 190.01(2), the Florida legislature has deemed carrying a concealed firearm a felony crime in the third degree. Statute 190.01(3) says, however, carrying a concealed firearm is permissible with a valid permit. The petitioner asserts that a police officer conducted an illegal investigatory stop and a search of his person without consent and without probable cause because there was no indication that he did not have a valid permit, and no other evidence of criminal activity.

Atty. Gen. Pamela Jo "Pam" Bondi and the State of Florida argue that any person is vulnerable to an investigatory stop and a search and seizure because carrying a concealed firearm, in and of itself, is illegal. In addition, having a permit is an affirmative defense, or excuse for a crime, so the stop and search is reasonable.

Yet, as clear as the sky is blue, the law says "This section [carrying concealed weapons] does not apply to a person licensed to carry a concealed weapon." If the language is directly written in the statute, it seems that it is more than just an exception, but the rule.

Although Florida's State Constitution and the U.S. Constitution prohibits unreasonable search and seizure, the State, in its heavy handed Brief on the Merits, uses flawed logic to assume that at the rate of 95 percent, persons who are carrying a concealed weapon ought to be presumed guilty of committing a felony.

"Given the small percentage of the population that is licensed to carry a concealed firearm, the overwhelming majority of firearms, or 95 percent, are not licensed to be concealed. Thus, an officer's suspicion that a firearm is not licensed would be reasonable because, in any given case, there would be, statistically speaking, a 95 percent likelihood of illegality."

As succinctly pointed out by ammoland.com, "In order for the State's argument to be valid, one would first have to ignore all visitors to our state from the 35 states with reciprocity. One would also have to ignore all of the circumstances where no license is required to possess a firearm, and it also assumes that every man, woman and minor child is carrying a firearm at all times."

Assuming that any individual carrying a concealed weapon is committing a felony, gives the State unfettered and unreasonable access to search and seizure of anyone who is presumably carrying a concealed firearm. This violates the 2nd, 4th, 9th and 14th Amendments to the Constitution, no? No, not if you believe Florida Atty. Gen. Pamela Jo "Pam" Bondi.

Pam Bondi is the same individual who boasted at the Republican National Convention in Tampa, "It is time to stop those who ignore the Constitution when it's expedient!" It appears Ms. Bondi is happy to pick and choose which liberties the Constitution protects as long as it suits her fancy, but what about the rest of us little people who believe in liberty across the board?

Since Bondi wants a win for the State in the case of Mackey v. State of Florida, she will misconstrue facts, ignore state laws, and negate the Constitution if she has to, in order to receive a favorable result. Bondi pretends to be supportive of the Constitution, when in fact she is the epitome of ignoring the Constitution when it's expedient! Remember folks: Forceful words and flowery commentary mean zilch compared to the truth.
